In all we finished the year with a modest gain in the bank account of \$597.51 over last year, which gives us a total of about \$6965. This is easily over our projected 2014 goal of \$6,750. We are now in a position to buy the new four (4) wheel trailer for which we have been saving. Hopefully, the new trailer will be in hand and ready for the beginning of faire season in March.
